The committee held 4 (Four) meetings during the FY 2022G, and its activities within the scope of its competence as following:

- Study the preliminary and annual financial statements for the fiscal year ending on 31/12/2022 and the auditor's notes on the financial statements and follow up on what has been done about them, and the results of the company's financial year review with the appropriate external auditors and management representatives and raise the recommendation for consideration for approval to the Board of Directors.

- Supervising the auditor.
- Study the management letter issued by the auditor.
- Studying the auditor's offers and recommending the appointment of the auditor for the year ending 12/31/2023.
- Studying compliance reports that reflect the extent of compliance with the statutory requirements and following up on the implementation of the recommendations contained in the reports.
- Review accounting policies and practices, including the consistency of these policies, annually.
- As well as the responsibilities above mentioned the audit committee takes it upon itself to carry out any other tasks assigned to it by the company's board of directors. It submits to the Council a periodic report on the examinations carried out by the committee, and its recommendations in this regard.







Internal and Financial Control and Risk Management System:

Control procedures and their effectiveness are of utmost importance and play a pivotal role in achieving the company's goals. The company's management is responsible for preparing a comprehensive and effective internal control system. The internal control system is based on the vision and assessment of the company's management to develop a control system commensurate with the relative importance of financial risks and other risks inherent in the company's activities.

With reasonable cost and benefit, limited regulatory controls in place. The internal control system is designed for the purpose of managing the risks of not achieving the objectives and not avoiding them. Therefore, the internal control system is designed to give reasonable assurances to avoid material errors and related losses

In addition to the aforementioned, the audit committee periodically reviews the reports prepared by the internal and external auditors, and these reports include an assessment of the adequacy and effectiveness of internal control.

Based on the above, we believe that the company has a sound and effective internal control system to a reasonable degree in terms of design and implementation, and there is no doubt about the company's ability to continue its business.

During the year, there was no material observation related to the effectiveness of the company's internal control system and procedures.
